Conditions pertaining to any proposed transfer of Seniority

1. Any person proposing to acquire Seniority must be the holder of a course Betting Permit granted to him/her by the Board of Horse Racing Ireland (HRI).
2. Any notification of an intention to dispose of a Seniority must be made in writing to the Bookmaking Division of Horse Racing Ireland within seven days prior to the publication of the monthly Seniority List.
3. Charges for advertising are as follows:
 - Charges for advertising will be charged in 6 month periods.
 - 1 seniority will cost €20 per month over the 6 month period (or €120 for 6 months).
 - The maximum charge to a Bookmaker will be €120 per month (or €720 for 6 months).This charge will be posted to your account on a monthly basis and paid by direct debit from your bank account.
4. No Seniority may be transferred without official notification to HRI.
5. All Registration Fees due in respect of the transfer of a Seniority may be paid to HRI on behalf of the racecourse executive by cheque/draft or by direct debit.
6. All payments due under existing agreements between Bookmakers and their Employees must be honoured in full before a transfer is registered.
7. The Bookmaking Division of Horse Racing Ireland acting as agents for each Racecourse may refuse to sanction any proposed transfer of Seniority.
